The signer of this form hereby acknowledges that I have voluntarily purchased a ticket or otherwise voluntarily chosen to participate in the activities of the Delaware River and Bay Lighthouse Foundation, Inc. (the "Foundation"), in connection with one or more Delaware Bay lighthouses which is owned by the Foundation; the Federal Government; or the State of Delaware, Department of State, Division of Historical and Cultural Affairs (the "State") and operated by the Delaware River and Bay Lighthouse Foundation, Inc. These activities included, but are not limited to, ferrying by motor vessels to offshore sites, climbing on and through various ladders, docks, boats, breakwaters, lighthouses and all and any related structures and/or objects all related to a guided tour of a Delaware Bay lighthouse.

I AM AWARE THAT THESE ACTIVITIES ARE HAZARDOUS, AND I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREE TO ACCEPT ANY AND ALL RISKS OF LOSS OF PERSONAL PROPERTY, INJURY, OR DEATH.

As lawful consideration for being permitted by the Foundation to participate in these activities of touring, viewing and experiencing the preservation of the Delaware River and Bay lighthouses and the related necessary facilities, I hereby agree that on behalf of myself, my heirs, beneficiaries, executors, administrators, successors and assigns, I hereby release, remise, acquit and forever discharge the Foundation, State, and Delaware Bay Launch Service, and their successors and assigns, and their past and present stockholders, directors, officers, commissioners, agents, servants, employees, parent entities, subsidiary entities, predecessor entities, affiliated entities, attorneys and insurance companies (hereinafter referred to as "Releasees"), of and from all, and all manner of, claims, demands, actions and causes of action, sums of money, attorneys' fees, costs, obligations, controversies, agreements, promises, commissions, damages, liens, judgments, executions, third party actions and causes of action and further including, without limitation, any and all suits at law, in admiralty or in equity, whether contract, tort, common law, constitutional, statutory or otherwise, including subrogation claims (whether by workmen's compensation carriers or otherwise), claims for contribution and/or indemnity, and liabilities of any kind or nature whatsoever which arise from or are connected with my participation in the activities offered by the Foundation. I further understand that it is not the purpose of the Foundation to teach safety rules nor is it the function of the Foundation, State, Federal Government, Launch Service, or their officers and /or directors to be the guardian of my safety.
